His goal is to live to be 100 years old and then one day reach Heaven. Duane Rost has served as an Elder, Song Leader, Teacher, and Writer at the East Hill Church of Christ. He is a wonderful example of a Christian Gentleman, Husband, Father, and Friend to all who know him.

John Goff Ballentine was born May 20, 1825 in Pulaski, Tennessee. He was the first of eight children born to Andrew Mitchell Ballentine and his wife, Mary (Polly) Tittle Goff. John graduated from Wurtemberg Academy, a private school in Pulaski for young men, and The University of Nashville. In 1848, he graduated from the Law Department of Harvard University and became a member of the faculty of Livingston Law School in New York City. He then began to practice law in Pulaski and Memphis, Tennessee and assisted his father in the management of the family's business.

Shortly after the Civil War started, he enlisted in the "Tennesseans in the Civil War" and became a highly-decorated Confederate soldier. After participating in many battles (some of which were in Giles County), he became a Colonel. After the defeat of the Confederate States of America in 1865, John returned to Pulaski to assist his mother in restoring and managing the family businesses and farms. His father, Andrew Mitchell Ballentine, a wealthy businessman and landowner in Tennessee and Mississippi, had died in 1863 without a will. After a lengthy process of settling the estate, a public auction by Chancery Court was held. At the auction, John Goff Ballentine purchased 6.68 acres of the property in November 1873 for \$3,941.50. The house and lots were located on East Madison Street and surrounding areas on East Hill. At that time, this property was not in the city limits. In October 1899 fire destroyed the Ballentine home with the loss estimated between \$9,000. and \$10,000.

In July 1900, John Ballentine contracted with E. L. Lytton (also spelled Litton) to build a two-story red brick Victorian mansion on the same site. The house was estimated to cost \$10,000. A lawsuit was filed against E. L. Lytton claiming inferior materials were used and cost overruns. The total cost to build the house was \$20,000. The Ballentines moved into the house in January 1901. At the time it was built, it was known as the finest house in Pulaski.

John died on November 23, 1915, and his wife, Mary Elizabeth Laird Ballentine died January 17, 1917. Both are buried in Maplewood Cemetery in Pulaski.

Another fire on December 25, 1935 claimed the Victorian mansion. The only members of the immediate family left were Miss Sallie and Miss Adalaide Ballentine. In 1937, the sisters rebuilt, on the same site, a large two-story Greek Revival brick mansion containing the most modern features of the day and with a portico supported by four massive ionic columns. The cost was \$75,000. When the East Hill church auditorium was built in 1952, these columns were preserved and now stand at the front of the building.

Miss Sallie died in 1944. After the death of Miss Adalaide in 1950, the Ballentine residence, land, and furnishings were sold at public auction in June 1950. The house was bought by W. K. Jones and wife for \$27,125. They subsequently sold the house for \$27,100 in June 1951 to become the East Hill Church of Christ. C. E. Nance, W. E. Walters, and Earl White were trustees of the church at that time.

The deed provided that no business or trade shall ever be carried on upon the premises. Other provisions were:

- The worship and church services shall at all times conform to the well-defined tenets and practices of churches of Christ in general.
- Instrumental music shall not be introduced and used in the worship.
- The missionary activities and program of the church shall not be carried on through organized missionary societies, or like organizations.
- Preaching the doctrine of premillennialism shall not be permitted on the premises.

The Second Street Church of Christ in Pulaski reached its membership peak in 1951, and in July of that year, the East Hill Church of Christ was begun from this congregation.

The East Hill church met for the first time at 509 East Madison Street on the first Lord's day in July 1951. Paul Matthews, then located in Columbia, preached the first sermon. Two hundred and seven enrolled for Bible study. The Ballentine property was purchased for \$27,100. The Second Street church paid \$10,000. of this sum, and the new congregation assumed responsibility for the balance. Eight months later the property was paid for completely. Folding chairs, song books, and other necessary equipment for worship were also purchased and paid for.

At this time, the congregation met for Bible study and worship in the downstairs portion of the Ballentine house. Duane Rost was the first song leader and served in that capacity for many years. In August 1951, Virgil Bradford moved to Pulaski from Plant City, Florida to work full-time with the East Hill church. The Bradford family lived upstairs in the Ballentine house. The church used the balance of the building for classrooms and general assembly.

A bulletin was first published on September 12, 1951. In September 1971, an offset printing press and other necessary and related equipment were purchased for the publishing of a bulletin.

A fifteen-minute daily radio program from 12:45-1:00 PM began in 1951 and continued until the spring of 1958 when only a fifteen-minute Sunday morning program continued. In 1954, radio rates were increased from \$5.25 per quarter hour to \$6.25 per quarter hour. In the early years of the program, other congregations in the county assisted in providing support for the broadcast. Later, this became a thirty-minute Sunday morning program and continues to this date.

The construction of the present auditorium, with a seating capacity of 600, was begun in March 1952 and was completed in December of the same year. The membership of the church at that time was approximately 225. Ben Brownlow and J. K. Woodard assumed the responsibility for building the auditorium, with Mr. Woodard in charge of the work. Total cost of the building was \$45,875. 55. J.K. Woodard, Earl White, Ben Brownlow, and others furnished materials and labor at cost. This saved the East Hill congregation at least \$20,000. Pews to seat 500 people were ordered for the auditorium for \$8,492. They were delivered in time for the first service in the auditorium December 21, 1952.

In 1953, a county-wide singing was held at East Hill with 658 present. Singing has always been an important part of the worship services at East Hill. Several singing schools have been held. Members from East Hill have sung at many funerals and continue to do so.

Elders were appointed on March 1, 1953. Those appointed were W. E. Walters, Bryan Pigg, Duane G. Rost, and W. L. Thompson. Two weeks later, M. C. Weatherman, R. M. Wheeler, William Wells, Earl White, Grady Crane, Charles Warren, Ben Brownlow, Oscar Batchelor, Marion Jones, and J. K. Woodard were selected to serve as deacons.

In June 1953, a house was rented at 406 West Flower Street for the minister and his family. In October 1955, the church purchased a lot at 544 East Madison Street from Mrs. Jennie Mae Colbert for \$2,500.00 to build a home for the minister. A new home was completed in 1956. In the summer of that same year, Virgil Bradford moved to Stoney Point, Alabama. The final payment was made on the preacher's home in February 1960.

Tom Holland and his wife moved from Minor Hill, Tennessee to work full-time with the East Hill church, and was the first minister to occupy the new home provided by the church. He continued preaching at East Hill through June 1958 when he decided to go into mission

work in Janesville and then Beloit, Wisconsin. The East Hill church supported him there. After he left Beloit, the East Hill church supported Welborn Hayhurst, followed by James Windham, Paul Reddin, and W.O. Mobley. Gordon McKool began full-time work in Beloit in April 1969. In 1976 he moved to Platteville, Wisconsin to begin a new work. East Hill supported him in this work.

Vacation Bible School (VBS) was conducted first in 1954 as a morning school. In 1963, a night school was begun with a visiting speaker for the auditorium class. The 1964 VBS, with different speakers for the adult class, averaged 291 in attendance. The five-day VBS in June 1965 averaged over 300 in attendance. In 2001, a Summer Bible School (SBS) program began, meeting on Tuesday and Thursday mornings to help young people know the Bible and to train them to be servants of God. For several years, the Boys and Girls Club of Pulaski attended the class. The VBS and SBS both were held each summer for a number of years.

The average attendance for Sunday School in 1957 was 317 and 340 in 1958.

Gilbert Shaffer and his wife, Mary, moved to Pulaski from Cookeville, Tennessee on July 7, 1958 to begin work on August 1, 1958. Brother Shaffer began preaching in 1926. Previously he served as an evangelistic singer working with preachers such as N.B. Hardeman, G.C Brewer, E.O. Coffman, C.R. Nichol and many others. He wrote and had published over 15 gospel songs. When he came to East Hill, he started the East Hill News as a monthly bulletin. He was instrumental in establishing a class to teach men to go out to preach in other congregations. Mrs. Shaffer began teaching a ladies Bible class meeting on Tuesdays during the school year. The ladies class was later changed to Wednesday mornings and continues to this day. They were very faithful in visiting members of the congregation, the sick, hospitals, nursing homes, funeral homes, and local businesses in the community.

Early in 1958, Bryan Pigg resigned from the eldership. In November 1958, J.K. Woodard resigned as deacon. On October 25, 1959, Melvin C. Weatherman was appointed to the eldership. W. D. Watson, C. W. Hart, Joe Harwell, Floyd Pierce, and James Holt were selected as additional deacons. Charles Warren resigned as deacon and moved to Lake City, Florida in 1961. In 1961, there were approximately 28 congregations of the Lord's church in Giles County.

Monthly support to the Tennessee Orphans Home was begun in the early part of 1961. For several years, ladies of the congregation went to the home regularly to assist with sewing and mending for the children. East Hill continues to support the home (now Tennessee Children's Home) monetarily and with supplies. Monthly support of Childhaven in Cullman, Alabama began in 1964 and continued for several years.

Between 1958 and 1960, 74 were added to the congregation. Of that number, 39 were baptized, 16 were restored, and 19 people placed membership.

Air conditioning was installed in the auditorium and classrooms of the building early in 1960. The parking area was paved in 1964.

Mission work was increased with the full support of William Hixon in Mason City, Iowa in June 1962. Later, Don Kinyon replaced him and worked there until January 1972. He was replaced by William E. Butler who moved from Dallas to begin work there on March 1, 1972. In 1973, Howard Merches moved to Mason City to continue the work in that area. East Hill had supported that work since 1962.

In July 1963, Luther Thompson resigned as an elder and moved his family to Elkton. In October 1963, Joe Harwell, Hugh Cooper, and Charles Gibbons were appointed as additional elders. Joe Harwell and his family later moved to Nashville. R.M. Wheeler resigned as

deacon in August 1964 since he now was living in Lawrenceburg. James Holt resigned as deacon in October 1963 to become full-time minister in Ardmore, and Ben Brownlow resigned as deacon in November 1963 since he had moved to Athens, Alabama. Charles Gibbons resigned as elder in September 1967 to preach full-time at Hester's Chapel.

Brother Gus Nichols held an eight-day meeting in 1963, speaking twice a day. During 1963, there were 12 baptisms, five restorations, and five to place membership at East Hill. In 1964, there were 13 baptisms, 2 restorations, and 40 placed membership at East Hill.

In 1965, there were 13 baptisms, 6 restorations, and 9 placed membership. Average attendance for the August 1965 meeting with Tom Holland was 364. There were 7 baptisms and 2 restorations during this meeting.

For a period of six years, a full Sunday's contribution per year was sent to the church in New Kensington, Pennsylvania. Assistance was given to the work in Korea in 1961, 1965, and 1967. The East Hill church has also assisted mission work in New Zealand, New York City, Montana, Idaho, West Virginia, Turkey, Brazil, Germany, South Africa, West Africa, North Carolina, the Fiji Islands, Spain, Pennsylvania, Ivory Coast of Africa, Ukraine, Ireland, Thailand, and many others. In June 1964, regular monthly support was begun for the church at Round Hill near Lynnville, Tennessee. In 1966, a donation was given to the Queens church of Christ in New York to help with the expense of preaching the gospel in connection with the World's Fair.

In September of 1966, full support was begun for Leland Rogers, the preacher in Cornelia, Georgia. The Cornelia church built a new church building and in 1969 purchased a house for the preacher and his family. In July of that year, Brother Wesson was employed to

preach. He was followed by Felton Spraggins in 1971. David Prevatt moved to Cornelia in February 1994 to work with the church there.

Since its beginning, the church has had several men to serve as treasurer: C. E. Nance, W.L. Thompson, C.W Hart, Malcolm Jones, Jeff Hamby, Rickie Britton, and Chris Cooper who presently serves.

Other activities and endeavors through the years include training classes for men and young people, ladies Bible classes, personal work classes, teacher workshops, Bible bowls, singing workshops, and other special classes. Several of the men who were members at East Hill have gone on to do full or part-time gospel preaching. Some of those were Cletus Nance, Tom Campbell, Charles Gibbons, James Holt, Everett McAnally, Horace Jones, Terrell Pitts, Herbert McNeese, Tim Fuqua, Josh Kraft, Jeremy James, and Brandon Britton.

In February 1967, Gilbert Shaffer moved to Lewisburg to work with the Farmington church. John Parsons, a second-year preacher student at Freed-Hardeman College was secured to preach for the East Hill church until September 1967 when Frank D. Young and his family moved to Pulaski from Russellville, Alabama to work full time. His wife, Gracie Young, was the daughter of Gus Nichols.

W.E. Walters resigned as an elder in July 1965 due to his declining health. He had served faithfully as an elder since the first elders were appointed at East Hill. In 1967, elders were Hugh Cooper, Duane Rost, and M. C. Weatherman. Grady Crane, C. W. Hart, W. D. Watson, and William Wells were deacons at that time. In February 1967, Floyd Pierce resigned as a deacon due to his health.

In an August 1967 meeting with Wendell Winkler of Ft . Worth, Texas preaching, there were 14 baptisms and 16 restorations.

The Beulah Lamar property, directly across from the church building on Madison Street, was purchased at public auction in the fall of 1968 for \$17,750. The old residence was removed from the property in the spring of 1969 for additional parking. The church auditorium and foyer were redecorated at this time.

The Frank D. Youngs left on December 1, 1970. Brother Young had accepted a position to teach at the Memphis School of Preaching. Clyde Woods became a temporary minister on the first of January 1971 until a full-time minister was obtained.

Support for the Korean Winter School was supplied in January 1971, and it was agreed to fully support this very effective mission effort on a regular basis.

Robert McAnally of Flint, Michigan accepted an invitation to move to Pulaski to begin full-time work on August 1, 1971. He, his wife, and three children moved into the preacher's home. An addition and assorted improvements were made to the home including a refurbished kitchen and re-roofing. The East Hill News began being published weekly, and continues weekly to the present.

Books were purchased in January 1972 to begin a church library with subsequent books to be added on a continuing basis. Willard and Judy Carr were given this responsibility and remain in this role. As of this time, the library consists of over 3,600 volumes. Most of these volumes have been donated in memory of friends and loved ones.

In March 1972, the property and house adjoining the Lamar lot and fronting on East Jefferson Street was purchased from Smith and Mary Woodard for \$14,000. The house was used to store furniture, clothes, wheelchairs, and hospital beds for loan, but because of repairs needed, the elders decided to have it torn down in October 1978. Medical equipment such as wheelchairs, walkers, etc. continue to be available to be loaned to those needing their use.

Grady Crane, one of the deacons, was in charge of the benevolent program, and he continued in that capacity for many years. In later years, Robert Clark was in charge of this program; now Ray Williford serves in this capacity. A visitation program has also been in operation for many years. Grady Crane and Jack Parks were in charge of the program in the early years. Charles Gulley is presently over this program.

During April 1972, two additional elders, C.W. Hart and Herman Mobley, were selected to join M.C. Weatherman, Duane Rost, and Hugh Cooper. Also appointed were seven deacons – Louie Fuqua, Malcolm Jones, Wayne Lovett, Jack Parks, Billy Pigg, Morris Tucker, and William Whitworth.

In 1972 a decision was made to purchase a 54 passenger bus to be used in youth activities and group transportation on church related activities. May 7 was designated as Bus Fund Day with all contributions over the necessary \$1,000 budget to go toward buying a new bus. The challenge was made for members to purchase a seat for a bus (\$150), ½ a seat, or ¼ seat so that the bus could be paid for without any financing. The cost of the bus was to be about \$8,000. The contribution for that day was \$5,404.85, breaking all previous records for contributions. Three hundred and thirty two were present for the morning worship.

A second Bus Fund Day was July 2, 1972. The contribution was \$3,202.14 which only left \$397.86 to be paid since other contributions had been made. The big red bus was parked in front of the building September 3, 1972 for all to see. A bus route began on September 10 on a limited basis and was expanded during the next few weeks.

In July 1972, the elders set \$1,500 as the proposed weekly budget. This represented an increase in benevolence, mission work, and a building fund of \$200 per week. A decision was made to utilize the local newspaper as a means of teaching concerning the Lord's work in this

area. Each ad would include a message and offer a Bible correspondence course as well as advertising upcoming meetings and events at East Hill.

In a November 1972 meeting with Charles Coil of Florence, Alabama, 20 people were baptized and 16 restored to faithfulness. Average attendance for the eight services of the meeting was 299. The average attendance for worship in 1972 was 343, and the average contribution for 1972 was \$1,247.23.

East Hill's first pictorial directory was published in 1973.

In the spring of 1975, a very successful bus ministry was begun and was in operation for many years. A second bus was added in November 1975. Through both donations and purchases, the bus fleet grew to five in 1977. Later the buses were eliminated, and vans were purchased.

Terry and Hellen Cordell placed membership at East Hill in October 1973, and Terry began full-time work with the youth in June 1974. From May 1975 to August 1977, Terry Cordell was employed as the youth minister and bus director at East Hill. He conducted a youth worship service for the children in the congregation and the bus children. April 18, 1976 the attendance for worship was 694 with 104 of those from bus routes. In the June 1976 Vacation Bible School, the average for the week was 554, averaging 179 a night on the buses. In August 1977, Terry resigned to go to the Pulaski Street congregation in Lawrenceburg.

A new education wing of approximately 6,000 square feet, adding nine classrooms, three offices, restrooms, and a supply room was completed in 1975. In preparing an entrance from the old building, a kitchen and office was completed. Ralph Gilliam, a contractor and member of the congregation, was in charge of the construction. Cost of the expansion was approximately \$100,000.

In June 1976, the elders decided the congregation would change to two worship services on Sunday morning at 8:30 and 10:30 with Bible school between services.

A 25th Anniversary service with Ted Kell preaching was held on July 4, 1976. A record attendance of 706 were present. A picnic lunch followed.

Herman Mobley resigned from the eldership in 1977 due to health problems. Tom Campbell and Louie Fuqua were appointed as elders in March 1977 and Jim Criswell, William Gooch, Jackie Hamby, Robert Reasonover, and Ronald Story were added as deacons. Duane Rost and M. C. Weatherman resigned as elders during this time. Tom Campbell later resigned to preach full-time.

May 15, 1977 worship service times returned to 9:30 for worship and 10:30 for Bible school. The attendance for morning worship was 516 with Jerry Humphries speaking in a gospel meeting. There were 45 responses to the Lord's invitation in the morning service and 14 in the evening service. Forty three people were baptized in 1977. Later, the services were changed to Bible school at 9:30 and worship at 10:30, as it is today.

In June 1977, the VBS had an all-time high attendance of 646 on Wednesday evening, with an average of 570 for the five nights.

Ron Holt, his wife, and two children moved from Florence, Alabama to begin work at East Hill as the associate minister in August 1977. He resigned in August 1978 and moved to Huntsville, Alabama to work as full-time minister for the Huntsville Park congregation.

The March 26, 1978 Sunday morning worship had 616 present with 451 in Bible class, Sunday night attendance was 411, and Wednesday night Bible class had 423. Bus attendance on Sunday morning was 106, Sunday night 127, and Wednesday 170.

In September 1978, Jim Azbell with his wife and two children moved to Pulaski for Jim to assume the duties of associate minister. He attended Harding College and had a background of experience in personal work, youth work, and bus evangelism. He left East Hill in November 1979 when the elders decided to discontinue the position of associate minister. Instead, the evangelistic money was pooled to support one man in the field.

Gordon McKool was selected to be the evangelist East Hill would support. He, his wife and children moved from Wisconsin in January 1980 to be at East Hill for approximately one year and then move to a mission field to begin or strengthen the cause of Christ. He would head up the personal work program while at East Hill. When the East Hill elders decided to support work in Dawson, Georgia, he did not want to move farther away from family and accepted a position with the congregation in White House, Tennessee in September 1980. Jim Parker, who had been filling in as preacher at Dawson, began full-time work there in 1984.

In June 1979, there were three elders who oversaw the congregation and work at East Hill. They were Hugh Cooper, Louie Fuqua, and C. W. Hart. Those who served as deacons at that time were Jack Parks, William Wells, Wayne Lovett, Billy Pigg, Grady Crane, Malcolm Jones, William Whitworth, William Gooch, Jackie Hamby, Robert Reasonover, Ronald Story, and Bobby Coggin.

Robert McAnally resigned in July 1979 to accept a position with the South Florida Avenue church in Lakeland, Florida. Thomas L. Orr was selected as the new minister. He and his wife, Ruth, and their six children moved to Pulaski in August 1979 from Greenville, Kentucky. Ruth was instrumental in encouraging several members to become involved with the World Bible School Correspondence Course. Tom left East Hill in 1982, and they moved to Lewisburg.

The church has had a number of associate ministers including Terry Cordell, Ron Holt, Jim Azbell, Gordon McKool, Danny Douglas, and Kelly Webb.

Bert and Dot Watkins moved from Kentucky to Pulaski in November 1980 for a short time before going to Dawson, Georgia in January 1981 for mission work there under the oversight of the East Hill elders.

April 6, 1980 (Easter Sunday) the attendance for worship was 531 . The average attendance for the 1980 VBS was 453. For a meeting with Guy N. Woods in November 1980, the Sunday morning attendance was 486, and the Sunday night attendance was 361. A record attendance for 1981 was 550 on April 19.

Lee Guthrie of Birmingham, Alabama was selected to be the second missionary family to the state of Georgia. He and Hattie, his wife, moved to Georgetown, Georgia the first of January 1982. They had lived in Pulaski from 1952-1958 when he worked with the Taylor Street congregation.

In October 1982, Glenn Colley began preaching for the East Hill church. Glenn and his wife Cindy moved to Pulaski from Bankston, Alabama to the East Hill preacher's home. Both of their children, Caleb and Hannah, were born while they were at East Hill. Caleb is now a faithful gospel preacher. They remained at East Hill until 1987 when he accepted the work in Salem, Virginia.

The elders made the decision to support Tim Fuqua in the two-year preacher-training program at the Memphis School of Preaching (MSOP). Tim and his wife Jennifer moved to Memphis in August 1983. He graduated in June 1985 and began full-time preaching. MSOP, a tuition free school, began in 1966 for the purpose of training men to be ministers of the gospel, offering courses in Bible and related subjects. Others from the congregation who

have been supported at the MSOP are Josh Kraft, Brandon Britton, and Jeremy James. East Hill continues to help support young men who attend the school.

Paul Sain was selected to succeed Glenn Colley as the new minister for East Hill. He, his wife, and three daughters moved to East Hill from Lebanon, Tennessee in December 1987.

A new publication, Truth in Love, was begun in 1988 and was mailed six times a year to other congregations and approximately 11,000 in Giles County. Many from East Hill, younger and older alike, gave of their time to make this happen. Truth in Love was a major effort, requiring hours of assembling, stapling, labeling, bundling, etc. to prepare the sixteen-page booklets. Numerous people have expressed interest in this evangelistic effort and their appreciation for the material provided.

Elders in 1989 were Hugh Cooper, Louie Fuqua, C. W. Hart, and Eldridge Woodard, who was appointed in November 1987. Deacons were Bobby Coggin, Charles Crane, William Gooch, Jackie Hamby, Malcolm Jones, Wayne Lovett, Jack Parks, Billy Pigg, Robert Reasonover, and William Whitworth.

An annual Truth in Love Lectureship, with 10-20 well-known speakers, has been conducted in May since 1991. Some of the speakers were Tom Holland, Curtis Cates, James Watkins, Robert Taylor, Winfred and Jimmy Clark, Garland Elkins, Dan Winkler, Dave Miller, B.J. Clarke, and many others. Attendees come from the area as well as many states. Students from preaching schools also attend. A book of the lectures is printed along with tapes, CD's, etc. that are available for anyone interested. These materials are also given to students from preaching schools. Hundreds of tapes and books are distributed throughout the United States and foreign countries. MSOP students have attended on Friday afternoons and Saturdays since the beginning and continue to do so.

Housing is provided for Friday night and meals are provided. A dinner on Saturday is provided for all lectureship attendees.

In 1992, a special tribute was given to 24 couples in the congregation who had celebrated their 50th or above wedding anniversary.

C. W. Hart passed away unexpectedly in October 1992. At that time, the C. W. Hart Scholarship Fund at the Memphis School of Preaching was established in his memory. Since then, numerous memorials have been made, and the fund now exceeds \$115,000. Many young preachers in training have benefitted from this fund.

In 1993, eight additional deacons were appointed – Mike Breeding, Willard Carr, Rickie Britton, Tony Creecy, Kenneth Frazier, Charles Gulley, Johnny Jackson, and Bobby White.

Of the 1993 East Hill budget, \$104,000 went to mission work. Over \$6,000 was sent to the Iron City area in July 1994 after a tornado struck the area. In October 1999, East Hill sent \$8,000 and many boxes (over 3400 pounds) of clothing to the Myrtle Beach church of Christ to provide relief to flood victims.

In July 1994, Kelly Webb with his wife, Terry, and their two sons, moved from Memphis to work with East Hill in personal evangelism. He worked with this program through 1996.

The elders decided in 1994 to have a special summer series on Wednesday evenings with different speakers. Speakers included ones East Hill was helping in mission or evangelistic work in various states. This summer series was continued for several years.

A “Young at Heart” Banquet honoring those members who are 60 years of age and above was held in February 1995. This became a regular event.

In November 1995, the church was saddened at the slaying of Carolyn Foster, a strong faithful Christian member of East Hill. She was one of two teachers at the Richland High School who were shot by one of the students. Nearly \$20,000 was given by friends and family to the Memphis School of Preaching in memory of Carolyn.

The church sponsored one minute spots, “A Better Life,” on the local radio station four times a day beginning in 1995.

East Hill began supporting the Radio Restoration Network with Roy Beasley in 1996 and continued in this work for many years.

Wayne Lovett, one of the faithful deacons, passed away unexpectedly in October 1996.

There were over 50 who responded to the invitation of Christ during 1996.

Members were encouraged to read their Bibles every day and read through the Bible in 1997. A daily reading calendar was prepared and provided for all members and others interested. This continues today.

Lynn Garner, one of the East Hill members, and Danny Douglas, who had been hired for mission work in March 1997, returned home after two weeks of traveling and teaching in the Ukraine. This was Lynn’s third trip there. In June 1997, they returned to the area to teach the gospel of Christ to people who have never heard of true Christianity. Lynn stayed approximately eight weeks, and Danny remained there to spread the gospel not only in Sevastopol in Ukraine, but in other parts of Crimea and eastern Europe. A number of East Hill members helped with toys and games for children of the orphanage in Sevastopol. Because of pressures from government officials in Ukraine, Danny returned home in late September 1997 with plans to go back when doors are opened to teaching the gospel. The East Hill elders

received a letter from citizens of Sevastopol expressing their gratitude for Danny's work there, for his service, and for the Christian example he set for them. East Hill continued to support him in this evangelistic work. Lynn returned to Sevastopol in 1998 for a month to continue teaching there, but was advised not to say anything in public. His teaching had to be done secretly in private homes.

In 1997, there were 10 baptisms, 18 requests for prayers and forgiveness, and over two dozen requests to place membership at East Hill.

After a sermon on marriage in February 1998, the following were honored with certificates: 57 couples of East Hill have been married over 40 years, 32 couples over 50 years, and 8 couples over 60 years.

High school and college graduates who attend East Hill have been recognized each year with a Bible and lectureship books.

Danny Douglas left after the May 1998 lectureship for Wales in Great Britain where he worked with the churches in Cwmbran and Newport. After about a year working in Wales, it was decided it would be best for him to relocate in Cambridge, England where there was a faithful and sound congregation. Relocating to that area enabled him to go about strengthening the small congregations nearby. In December 1999, Danny moved to Peterborough, England but continued to preach and teach in Cambridge regularly. There was more opportunity for evangelism in Peterborough, a growing industrial area near two American military bases.

In June 1998, Kenneth Frazier was added to the eldership, joining Hugh Cooper, Louie Fuqua, and Eldridge Woodard. He resigned in 2004. He had faithfully served as a deacon and teacher at East Hill for several years.

The East Hill church began going “around the world” in 1998 via the internet. The eldership encouraged the development of these communication lines and teaching of others throughout the world with faithful and sound materials. This continues to be a very effective means of spreading the gospel of Christ to people in foreign countries as well as in the United States. An internet homepage was developed, www.easthillchurch.org. Requests for materials, lectureship books, and tapes are received almost daily.

The August 16, 1998 attendance was 413, and the contribution was \$8,207.

East Hill began assisting in a new endeavor with the work in Kenya through the work of James and Barbara Jones and World Mission Radio. Support for this work continues today.

Three new deacons were added in June 1999 – Jeff Hamby, Joey Hamby, and Timothy Mayfield. Later, Timothy Mayfield moved to Huntsville, Alabama.

Brandon Britton was added to the evangelistic staff at East Hill in 1999 after completing studies at the MSOP. He began a “Learning the Bible” training class for the young people. “Sonshine,” a publication especially for the youth, was begun.

By August 1999, there were 25,000 copies being printed of each issue of the Truth in Love. Copies were being mailed to over 200 congregations. Additional copies were often requested.

Every Wednesday night at 6:15 members of East Hill conduct a devotional at the Ivy Crest Assisted Living in Pulaski. Attendees sing songs, have prayers, and study God’s word with the residents and several from East Hill.

A farewell gathering was held in October 1999 for Louie and Wilma Fuqua. Louie had retired, and they moved to Lafayette to be near family. Louie faithfully served as an elder of East Hill for 22 years.

In 1999 there were 13 baptisms, 21 restorations, and 4 placed membership.

In June 2000, Danny Douglas returned to Tennessee. He then began to preach for the Berea congregation near Columbia.

The elders told the congregation of tentative plans for expansion of the East Hill building and asked members to give an extra amount to the Building Fund. A goal of \$100,000. was given before work could begin.

In 2000 there were 16 baptisms, 60 restorations, and 9 placed membership.

The elders made the decision to seek out struggling congregations of the Lord's church who are unable to afford gospel meetings and support Fred House in preaching in these meetings. The first one was held in Saucier, Mississippi with several others following.

VBS was held in July 2001 with the first night attendance of 355.

By 2001, East Hill was sending out almost 27,000 copies of Truth in Love to homes in Giles County, other congregations, and numerous foreign countries. This was an evangelistic work of the church at East Hill to spread the gospel of Christ throughout the world.

The East Hill congregation marked its 50th anniversary on July 15, 2001 with a special homecoming day and Tom Holland speaking. After services, a covered dish dinner was held at the National Guard Armory with a special program following.

Deacons at that time were Mike Breeding, Rickie Britton, Willard Carr, Bobby Coggin, Charles Crane, Tony Creecy, William Gooch, Charles Gulley, Jackie Hamby, Jeff Hamby, Joey

Hamby, Johnny Jackson, Malcolm Jones, Timothy Mayfield, Jack Parks, Billy Pigg, Robert Reasonover, Bobby White, and William Whitworth.

In August 2001, Jackie Hamby entered eternity after a long illness. He served faithfully as one of the deacons for many years.

In order to expand the East Hill building, the following houses and lots on Highland Avenue, directly behind the existing building, were purchased:

- The Rufus Campbell house and lot, November 1999, \$97,650.
- The Clarence Abernathy house and lot, April 2002, \$95,000.
- The Edward Gowan house and lot, May 2002, \$85,000.

In June 2002, East Hill sold two lots facing East Jefferson Street to James M. Bryant for \$10,000 each. He, in turn, was to move the two brick houses from the Highland Avenue property to East Jefferson Street. The remaining house on the Highland Avenue lots was torn down to make way for the East Hill building expansion.

Every year of its existence, East Hill has held one or more gospel meetings with speakers from all over the country. This includes Perry Cotham, Gus Nichols, Tom Holland, Guy N. Woods, Wendell Winkler, William Woodson, Thomas Warren, Bobby Duncan, David Sain, B. J. Clarke, and many others.

In February 2002, additional elders were selected – Joe Cooper, William Gooch, and Kelly Webb.

William Whitworth passed into eternity in April 2002 after faithfully serving as a deacon for 30 years. Grady Crane resigned as a deacon in May 2002 because of his health. He and his wife moved to The Hewitt House Assisted Living where he passed away in January 2003.

Randy Britton, Tim Townsend (later moved to the Nashville area), and Mark Woodard were added as deacons. Mike Breeding resigned as a deacon in September 2004.

The average attendance in 2002 for the Sunday morning worship service was 368 and 278 for Bible class. Average attendance for the Sunday night service was 253, and Wednesday night service averaged 259. The 2002 average Sunday contribution was \$7,110. During the year 2002, there were 16 baptisms, 19 restorations, and 22 placed membership.

Jeremy James graduated from the MSOP in June 2002 and began full-time preaching.

William Gooch made the transition from this earthly pilgrimage to eternity in a tragic accident in March 2003. He had faithfully served as an elder for the past year.

Jeff Johnson and family moved to the Memphis School of Preaching in June 2003 to prepare for the ministry, graduated in 2005, and accepted a position preaching in Chattanooga. He later moved to the East Tennessee area.

Over 40 members met in August 2003 to prepare the lots purchased for future building. Rocks were picked up and the vacant lots cleaned. After the work was done, a cookout was enjoyed.

In November 2003, the Wednesday Ladies Bible Class invited all employees of the Pulaski Police, Pulaski Fire Department, Giles County Ambulance Service, Pulaski-Giles County E911, Giles County Sheriff's Department, and the Giles County Rescue Squad for lunch. The ladies prepared an abundance of delicious food for all to enjoy. It was our sincere desire to express appreciation for the dedicated servants of our community.

During 2003 there were 9 baptisms, 58 restorations, and 12 placed membership. The average attendance in 2003 for the Sunday morning worship service was 362; Sunday Bible

class attendance was 281. The Sunday night attendance was 259, and the Wednesday Bible class was 253. Weekly contribution average for 2003 was \$7,231.

A one-time contribution the last Sunday in 2003 for the building fund was \$22,450. Final total reported in January 2004 was \$26,450. By January 18, 2004, there was close to \$130,000 in the building fund. The three pieces of land adjacent to the church building were purchased and paid for, houses moved, and land cleared. Elders set a goal of \$600,000 to have in hand before beginning construction. The last Sunday in September 2004 was designated as a special day of emphasis toward this goal. All contributions over \$7,000 went toward the goal. The contribution that day was \$56,512. The last Sunday in the months of October through December, over \$200,000 was given toward the building fund. At the end of the year, the building fund was \$370,000. The last Sunday of the month contribution continued to be dedicated to the building fund in 2005 and through March 2011.

In January 2005, Dave Miller, the Director of Apologetics Press, presented a 3-day series on The Quran, Islam, and New Testament Christianity. In July, he presented seven lessons on “The Silencing of God” in the adult class of VBS.

A 10-class series on “The Growing in Faith and Knowledge” classes were taught by David Sain.

Johnny Jackson was selected as an elder of the church in April 2005 but resigned from the eldership in May 2008.

In September 2005, East Hill responded to a call from those affected by Hurricane Katrina. Members of East Hill, with other surrounding congregations helping, took a 53-foot semi-truck loaded with supplies to the Orange Grove church of Christ in Gulfport, Mississippi. Several of the men went and helped unload and distribute food and supplies. The next week

another 53-foot semi-truck was loaded with food and supplies and taken to other areas in need. Nine members went to deliver the supplies, and some of them stayed to work for several days. The next morning, another load was taken to Picayune, Mississippi.

In October 2005, Kenneth Frazier, a Bible class teacher and former elder, departed from this life suddenly on Saturday after being actively involved in the worship on the previous Sunday.

The November 6, 2005 attendance for Sunday worship was 431.

The Gospel Broadcasting Network (GBN) began on Friday, November 26, 2005 on cable systems, dish networks, internet streaming, video, etc. preaching and teaching the gospel 24 hours a day, 7 days a week. At that time, GBN was not available on the local cable provider, but was added in August 2007 on Tuesday evenings from 6:30-8:30. GBN serves two purposes. One is to present the gospel to those who might never visit a church of Christ, and to provide Christians with godly and edifying programs they can enjoy on television. Elders at East Hill have been very supportive of GBN. A satellite dish was installed at the East Hill church building for anyone to be able to come and watch programs. GBN is now under the oversight of the eldership at Southaven church of Christ in Southaven, Mississippi.

Robert Hatfield, while a student at Freed-Hardeman University, wrote a series for the East Hill bulletin on “Why I Am a Member of the church of Christ” and another series on “Examine Yourselves Whether Ye Be in the Faith.” He also became one of the speakers on GBN. “Voices from the Past” on GBN includes speakers from the Truth in Love Lectureships of the past. Paul Sain and Brandon Britton also had a 30-minute program “Speaking the Truth in Love” on GBN.

The last Sunday in December 2005, the contribution was close to \$30,000. This brought the building fund to almost \$592,000. By February 2006, the building fund goal of \$600,000 had been met. Many members gave to the building fund as memorials for friends and relatives. Ground was broken as soon as weather permitted with plans for the building addition to be completed in eight months. By then, over \$640,000 had already been given toward the building construction. This did not count almost \$300,000 for the land and preparation. The last Sunday in the month contributions over \$7,000 were still being applied to the building fund. It contains offices, classrooms, library, and restrooms. Downstairs are restrooms and a large fellowship room that is used for many activities. It can also be used as a storm shelter for the community.

Over 20 workers of the East Hill family went to the church at Grand Blanc, Michigan in June 2006 to conduct their VBS on the Miracles of the Bible.

The Certificate of Occupancy for the new building was received in February 2007. Only general cleaning and waxing of floors needed to be done before moving in.

The theme for this year's "Young at Heart" (or "Senior Saints") banquet honoring members over 60 years of age was "Precious Memories." This was held March 10 and was the first activity held in the new building

In May 2007, Robert Hatfield began working with the congregation for the summer months during his break from Freed-Hardeman University. He spoke on the local radio station on Sundays and the one-minute spots during the week, taught the teen class, wrote material for the bulletin, preached at times, and directed the Ivy Crest devotionals. He continued to work with East Hill after graduating from Freed-Hardeman.

Seventeen of the East Hill family traveled to New Orleans in July 2007 to conduct a VBS with the Chalmette congregation. This congregation was one of the many that suffered greatly from Hurricane Katrina.

In the 1920's, at the Ryman Auditorium, brother N.B. Hardeman proclaimed the gospel of Christ to overflow crowds, and to thousands more via radio. GBN sponsored "GBN at the Ryman – The Tabernacle Sermons of Today" July 1-3, 2007 with outstanding faithful preachers speaking. For those who could not go to Nashville or hear the live satellite broadcast, all were invited to come to the East Hill auditorium to participate in this worship service.

Brandon Britton announced that he would begin working with the Fairview congregation in Giles County in August 2007. He and his family were honored with a potluck lunch on his last Sunday at East Hill. Kelly Webb, one of East Hill's elders, went with Brandon to Fairview, along with several other members of East Hill. The following deacons also went to Fairview – Randy Britton, Jeff Hamby, Joey Hamby, Jack Parks, and Bobby White.

Seven members made the trip to Lafayette, Tennessee in February 2008, taking four truck and trailer loads of supplies to aid those people in the area after a tornado went through Macon County. Over the next few weeks, additional supplies and money were sent to the area for those in need.

The elders announced that 500 new song books were being purchased for the auditorium. Members could pay for a book, or more, and have a label placed in the back of the book in memory, or honor, of family members or friends and specifying who purchased the book. All books were purchased by members.

In April 2008, Hugh Cooper resigned from the eldership after more than 45 years as a vital and faithful part of the East Hill eldership. He passed from this life into eternity in November 2008. He was a great Christian, a faithful elder, and a lover of the truth.

East Hill has been blessed in many ways, but one of her greatest assets is the talented, loving, and efficient teachers who share their Bible knowledge. Some have taught faithfully for years and years. Some have even had the privilege of teaching the children of ones they taught years ago.

Malcolm Jones resigned as a deacon in August 2008 after years of service in the kingdom of God. He served as treasurer for many years and maintained attendance records through the years. He passed away in December 2009.

Members sacrificed, giving liberally, month after month to pay off the building debt. The expansion project was approximately \$1,500,000. In November 2008, the balance of the debt was down to \$345,800. The fourth Sunday contribution (over \$7,000) continued to go in the building fund.

In 2008, the East Hill bulletin became available free via the internet.

In February 2009, Tom Holland delivered four lessons at East Hill. Former preacher at East Hill, he is a nationally-known speaker, writer, lecturer, television personality, and appears regularly on GBN. Dozens of sets of CD's of his lessons were ordered.

Johnny Jackson and Larry Thomason were appointed as elders of the congregation in February 2009. Larry Thomason later resigned from the eldership. Eldridge Woodard resigned as elder because of his declining health. He served for over two decades as an elder at East Hill, always standing for the truth. He taught the adult auditorium Bible class for several

years, walking through many books of the Bible. He made the transition from this earth on November 3, 2010.

There was a Teachers Appreciation Dinner in August 2009 for those who teach, those who have taught, and those who would like to teach in the future.

Chris Cooper who works with East Hill's web site, www.easthillchurch.org, reported that East Hill's web site had 40,000 hits in July 2009. About 20,000 of those hits came from Russia. The church is involved in work that is literally reaching around the world, and people around the world are taking advantage of it. All of the sermons at East Hill, bulletins, lectureships and books, etc. are constantly being uploaded to the web site for all to visit.

At the end of the year 2009, there were 12 deacons – Steve Alsup, Rickie Britton, Willard Carr, Joe Christopher, Robert Clark, Bobby Coggin, Tony Creecy, Charles Gulley, Nathan Hale, Joel Orton, Dave Stampfly, and Mark Woodard.

The contribution toward the building fund for the last Sunday in 2009 was almost \$13,000. This reduced the amount owed to under \$180,000.

Some of the auditorium pews were relocated to allow space for the new Welcome Center in the back of the auditorium. This new area is to welcome visitors, promote church fellowship, and create better options for videotaping the weekly services, gospel meetings, lectureships, etc. Pews were moved to the fellowship hall downstairs, providing space for sitting while waiting in line at dinners. Some pews were also moved to the SBS classroom.

The first Christian Servants Day at East Hill was held on February 10, 2010 with Tom Holland as the speaker. A Bible teacher's workshop for ladies was taught by April Meacham and Teah McWhorter. The Christian Servants Day became an annual event. This day is not

only for East Hill, but other Christians as well. It was planned to instruct spiritually, uplift, inspire, and challenge those who attend to be better Christian servants.

In 2010, East Hill began hosting the Friday night area-wide singing in April each year. People come from Alabama and Tennessee to praise the Lord in song. A meal is provided for all attendees after the singing.

Ray Baker, a Freed-Hardeman University student, was hired for several weeks in the summer of 2010 to work with the youth. Youth Day, hosted by East Hill was Saturday, October 2, 2010 with a speaker, singing, fellowship, and games.

Joe Christopher became an elder of East Hill in November 2010, joining Joe Cooper and Johnny Jackson. He had served as a deacon charged with overseeing the educational program of East Hill.

Dan Winkler and Tom Holland were speakers for the Christian Servants Day in February 2011. Christians from 38 different congregations heard these challenging lessons. All of the lessons were also broadcast over the internet.

Robert R. Taylor, Jr. taught a series of lessons in March 2011 on “A Study of the Godhead.” He is a well-learned Bible scholar and has spread the gospel for over 60 years. He has been a speaker on most of the lectureships held at East Hill.

The fourth Sunday in March 2011 contribution of almost \$14,000. completed the building debt. On Sunday, April 3, 2011, members gathered for lunch after morning worship, and then rejoiced with a “note burning.” It was truly a day to remember as the milestone of eliminating the debt on the building addition was celebrated.

Sunday, July 3, 2011, East Hill church celebrated the 60th anniversary with Tom Holland, Bob McAnally, Glenn Colley, and Brandon Britton as speakers. Nearly 400 attended including many visitors. Almost a dozen of the original members when East Hill began were present.

The elders of East Hill decided to emphasize evangelism during the month of October each year with special speakers who are actively involved in missions. This month is to provide more opportunities to be challenged from God's word concerning evangelism. An evangelism workshop was held with speakers from the Northwest church of Christ in Lawton, Oklahoma.

Dave Miller presented a six-lesson study on "America's Most Pressing Concern" in November 2011. This was a sequel to "The Silencing of God."

Eighteen workers arrived in November from the Memphis School of Preaching to conduct a campaign in the Pulaski area. Almost 3,300 doors were knocked, excellent contacts were made, and several Bible studies were scheduled.

A Bible Reading Marathon began on Wednesday, December 28, 2011 at 9p.m. and did not stop until Revelation was read by different East Hill readers, some 70 hours later. The marathon was an online event viewed from East Hill's website. While showing that the entire Bible can be read in just three days, it makes reading the Bible through in 365 days look easy. This was to encourage members to make a commitment to read through the Bible in 2012.

Saturday, February 28, 2012, Christian Servants Day speakers were Dan Winkler and Tom Holland. Their subjects were "Lessons on Involvement." Video of all of the lessons are available in East Hill's online video archives. CD's are available for the lessons and DVD's for "Tom's Pastime on the Porch."

Support was begun for the Latin America Missions. Brandon Britton is involved with this work.

With the completion of the new teacher's resource room, a Teachers Enrichment Series was held for a special time of instruction and training for present, past, and future teachers. During the 2012 SBS and VBS, students brought their coins to go toward the good work that is done through the Latin America Missions Change the World Campaign. Both children and parents brought hundreds of coins resulting in a large jug almost full.

Youth Day was held at East Hill on October 6, 2012 with Cliff Goodwin and Lonnie Jones speaking.

Over 200 bags are prepared and distributed to shut-ins, assisted living, and nursing home patients each year during the Thanksgiving holidays.

The first community food giveaway was held on Saturday, December 8, 2012, when approximately 30,000 pounds of food was distributed to over 500 families. Many of the East Hill members, young and older, gave of their time to help prepare for this special effort by taping and labeling boxes, filling boxes with food, greeting those who came, assisting them with their boxes, showing the love of Christ to the hundreds who came. This became an annual event in early December.

Christian Servants Day was February 21, 2013 with Dan Winkler and Tom Holland speaking on the topic of "Lessons on Discipleship."

The Teachers Appreciation Banquet was April 20, 2013 with Bill Irby as the evening speaker.

In 2013 the SBS and VBS again joined hands with the Latin America Missions by bringing coins to help boys and girls in Latin America have their own Bibles. Brandon Britton

accepted the jar of change and bills which totaled \$638. The last Thursday class of the SBS set a record for attendance of 106 students.

Friends and Family Day began being observed in August 2013. This has become an annual event where members invite former members, friends, and family to attend worship and dinner following.

In 2013, there was a major update to the auditorium with new carpet, new padding for the pews, new storm windows, etc.

The Unite Program, designed for the young people, was initiated in November 2013. Dozens of memory verses were learned, deeds of encouragement were done through the Barnabas work, “Know the Books” class learned the books of the Bible, scrapbooks for the year were made, and younger women are being taught by the older women to be virtuous. Young men were taught to speak in worship and have a desire to become elders and leaders in the future. Unite is a multi-faceted program for the youth that is designed to promote spiritual growth in Bible knowledge and to cultivate talents that can be used in serving the Lord.

Robert Hatfield announced in May 2014 that he and Emily would be moving to South Carolina to work with the North Charleston church of Christ. They left in July 2014.

The SBS, formerly held in June and July, was modified to be a six-session schedule in June. The VBS continued in July. James Watkins taught the adult class, and Chris Clevenger taught the teen class in 2014.

East Hill assisted in providing support for Brandon Grieves as he entered the MSOP in July 2014. After graduation, he became the minister for the Fairview congregation in Giles County.

For Friends and Family Day, August 10, almost 300 gathered to worship God and enjoy fellowship with many former members and visitors,

Jonathan Burns was selected by the elders to come to work with East Hill. He is a 2013 graduate of the MSOP and came from the Arrington, Tennessee congregation. He and his wife Kelley moved to Pulaski and began working at East Hill on August 31, 2014. There was a welcome dinner for them on that Sunday.

September 27, 2014 was designated by the elders as a night of recognition and to honor participants of the Unite Program. Many have participated in this program of learning and growing in knowledge.

The December 2014 food giveaway was a tremendous success with approximately 380 boxes of food given to those in need. In addition to the annual giveaway, food is given out regularly to those who come to the church office asking for help. A food pantry is stocked by the East Hill members.

Christian Servants Day on February 28, 2015 had Tom Holland and Dan Winkler as speakers.

East Hill hosted a Ladies Day on April 11, 2015 with Tish Clark as the speaker. She challenged the ladies to even greater service to the Lord. Many visitors came from Alabama and Tennessee.

The SBS was held again in June with the Boys and Girls Club attending too. The first day of attendance there were 104 present.

On fifth Sunday afternoons, Spiritual Men and Spiritual Women classes were held to assist members in their spiritual development and growth.

A contract was officially finalized in May 2015 with the Pulaski Electric System (PES) to have Channel 98 (later changed to 22) airing the GBN programs locally 24/7. Special programming by East Hill and the Fairview congregation allows their sermons and special programs to be aired. This great work in evangelism is kept going financially by the two congregations.

Bob McAnally, former minister at East Hill, was the speaker for the August Friends and Family Day.

September 26, 2015, the Unite Banquet was held as a night of encouragement and honor for those who have worked so hard this past year, and encourage them to keep working for the Lord.

Paul Sain left East Hill in October 2015.

During 2015, the children's classes changed to the Engraving Heavenly Truths materials. This material is filled with scripture references, Bible accounts, Bible facts, and great teaching.

At the December food giveaway, 240 boxes were distributed.

Deacons at the end of 2015 were Steve Alsup, Rickie Britton, Willard Carr, Bobby Coggin, Chris Cooper, Charles Gulley, Nathan Hale, and Mark Woodard.

For the Christian Servants Day in 2016, Glenn Colley and Tom Holland spoke on "The Family." There was a record setting attendance of 216, representing 30 different congregations. Both of these men presented lessons that were relevant and challenging to Christian servants.

In March 2016, Bobby Coggin passed from this life into eternity. He had faithfully served as a deacon for many years.

Ladies of East Hill attended a Ladies Retreat on April 1 and 2, 2016 at the Graymere Retreat Center. The theme was “A Titus 2 Woman.’

The focus in 2016 was on the SBS in June, and the church did not have a VBS. This year’s lessons for SBS were on the Parables.

August 7, 2016, East Hill celebrated 65 years of faithful service to God with Tom Holland as the special speaker. There were many visitors and people who had served at East Hill in the past in attendance. There were 210 in Bible class, 288 in morning worship, and 181 for Sunday night.

East Hill and Fairview hosted the first Teen Leadership Conference at East Hill on August 13, 2016 with Kyle Butt giving four challenging lessons. Three hundred and sixty five attended from 37 different congregations, and 265 watched online (including a group from New Zealand). The two congregations worked together to make the first teen conference a great success. CD’s and DVD’s are available.

In the October missions month, Billy Bland and James Jones were speakers, giving reports of the mission work in which they are involved. Jonathan Burns went with Billy Bland on a 20-day mission trip to the Philippines and Singapore in November 2016.

In the fall meeting in October 2016, the speaker was Mike Vestal of Midland, Texas. His subject was “Can the Lord Depend on You?” These lessons were broadcast on PES channel 98, and CD’s and DVD’s are available.

With the large group of members working, all 240 food boxes were put together for the December food giveaway in record time.

The East Hill elders expressed a desire to the members to help send money to the Gatlinburg church of Christ to help with the recent fire disaster in Gatlinburg. Their building was destroyed, and so were several members' homes. Over \$5,000 was donated and forwarded to the Gatlinburg church in December 2016.

Christian Servants Day was held February 25, 2017 with Glenn Colley and Keith Mosher speaking. Both men delivered excellent lessons on "Christian Joy."

Sheila Butt was the speaker for Ladies Day in March 2017. She spoke on a "Recipe for Life." Her lesson was live streamed with CD's and DVD's available.

The ladies of East Hill began a new project in 2017, the Teddy Bear Project. Bears are made by the ladies and given to the local hospital, doctors' offices, and emergency personnel to help children who are hurting.

The annual March meeting was held with Gary Hampton speaking. His topic was "Does the Devil Know You?"

The Truth in Love lectureship was held May 10-14, 2017 with 16 different speakers. The theme of the lectureship was "Upside Down Reaching the World." Each of these lessons were created and presented in a way that could help for years to come. Lectureship week is about spending the time together in God's word and focusing upon heaven. Lectureship media is offered now in four forms: Blu-Ray, CD sets, DVD sets, and Memory Key. Lessons are also available in book form. Lectures also air on the local Pulaski Bible Broadcast.

On Sunday, June 25, 2017, three new deacons were added to help with various works of the church – Jim Calahan, Dennis Collins, and Phil Glover.

The SBS 2017 was a huge success with great participation from other congregations and some children who came last summer with the Boys and Girls Club. The club was closed this summer.

The second Teen Leadership Conference sponsored by Fairview and East Hill was held at East Hill August 12, 2017. “Transformed” was the topic with Glenn Colley, Craig Evans, Chad Landman, and Mary Lauren Doggett (for the girls) as speakers.

The conference was followed the next day with Friends and Family Day at East Hill. A great number of people joined us for Bible class and worship followed by lunch and fellowship.

Money was taken up and \$4,700 was sent to a congregation in Vidor, Texas as part of the Texas Relief Effort. Many members of that congregation lost their homes and possessions from the flooding of Hurricane Harvey when they had over 50 inches of rain. Contributions were to help families rebuild their homes.

The October Missions Month is important because it gives an opportunity to see the great works that East Hill supports. The 2017 month featured Billy Bland, Tavera Hanna, and James Jones. All of these men work diligently to further the cause of Christ.

Cliff Goodwin was the speaker for the fall meeting October 22-25, 2017.

All of the East Hill services are now on TV (live and prerecorded) on the Pulaski Bible Broadcast.

Jonathan Burns left on November 23, 2017 for an 18-day mission trip to Singapore and the Philippines. He spoke in the Four Seas Bible College in Singapore and worked with the

Commonwealth church of Christ in the Philippines. He, along with Billy Bland, Tim Hayes, and Tim Burrows, went to four different countries doing various good works.

With an emphasis on security, cameras have been installed and are monitored during every service. All outside doors are locked during worship services, and a security team is on the front door. Other steps were taken to make East Hill a safe place to worship, study, and attend all functions.

Thanksgiving bags were taken to shut-ins in November. The annual food giveaway was held December 9, 2017 with 192 boxes given out in less than two hours.

In December, \$1,120 was sent to World Mission Radio (James Jones) to provide relief for those in need in Kenya.

Christian Servants Day was held February 24, 2018 with Tom Holland, Glenn Colley, and Keith Mosher speaking on “Serving Like the Master.” Lessons are available on CD, DVD, and other media types.

A large group of ladies enjoyed Ladies Day in March 2018 with Cindy Colley as speaker. Her topic was “Be Still and Know.”

The spring meeting was held March 11-14, 2018 with John DeBerry.

The 2018 lectureship was held May 9-13 with 16 different speakers on “How to Survive Temptation.”

Summer Bible School was held in June with classes studying “The Miracles of Jesus.”

About \$3,000 was given for those in Africa who were having emergency medical needs.

The Teen Leadership Conference was held August 4 with Craig Evans, Chris Perry, and Sheila Butt (for girls) speaking. East Hill and Fairview members work together to make this day a success.

The Senior Saints Dinner for those 60 and over was held July 28, 2018.

The Friends and Family Day was held August 12, 2018 to reflect over the past 67 years and to strengthen future generations.

Larry Acuff was at East Hill speaking in the fall meeting October 21-24 on a variety of gospel subjects. He is presently a preacher in the Chattanooga area.

Jonathan Burns was in Singapore from November 20-December 5 working with the Four Seas Bible College and missions. While there he worked with the school helping them prepare lessons for DVD's, prepared special USB thumb drives for members, and spoke at locations across Singapore. A large amount of resources was prepared for Christians in ten different nations to take home and use in helping the cause of Christ.

In the food giveaway December 8, 2018, 168 boxes of food were distributed to those in need.

Christian Servants Day was held February 23, 2019 with Tom Holland, Glenn Colley, and Keith Mosher speaking on the subject, "The Location of Service." This day was filled with great lessons, wonderful fellowship, many visitors, and was the biggest Christian Servants Day ever at East Hill. During the services, Tom Holland was honored for his years of dedication to the East Hill Christian Servants Day. He departed this life for eternity on April 25, 2019 after a life of service to the Lord.

East Hill members donated \$1,970 to the Caverns Road church of Christ in Marianna, Florida after Hurricane Michael. Many in the church there and community lost their homes, jobs, and businesses. Christians were able to meet many of their needs with the donations provided.

The spring meeting with Phil Sanders of Edmond, Oklahoma was held March 10-13, 2019. He is the speaker for “In Search of the Lord’s Way,” a nationally broadcasted television ministry of the Edmond church of Christ. This program is now broadcast on the local radio station on Sunday mornings.

Ladies Day with Denise Martin as speaker was held April 13. Her subject was “Stitched with Love.”

The May lectureship with 16 different speakers was on “The Family of God.” The lectureship is valuable for all Christians and something to be enjoyed from year to year. A book of all lectures is available as well as CD’s, DVD’s, Blu-Ray Disk, and MP3 thumb drive.

In 2019, East Hill did not have SBS, but had VBS in June. The subject was “The Bad Guys of the Bible” with different speakers for the adult and high school classes. VBS was a great success with great attendance, great lessons, and great fun together.

For the Friends and Family Day on August 11, members were encouraged to invite a friend to hear the lesson on “Loving the Lord.”

During 2019, two major building projects were completed – the Ballentine ramp to the back of the building and an electrical upgrade.

The fall meeting speaker was Derrick Coble of Sparta. The topic of the October 20-23 meeting was “Life Changing Stories.”

Saturday, November 9, East Hill sponsored a Bible Class Workshop for congregations in the area with April Meacham and Teah McWhorter as the teachers.

The elders challenged all members to invite one person each week to the services at East Hill.

Thanksgiving bags were delivered to over 240 shut-ins on November 17.

Jonathan Burns left November 18, 2019 for a 16-day trip to Singapore. While there, he was able to speak eight different times to a variety of individuals. The Four Seas Bible Lectureship was blessed with a year of growth and reached its highest attendance ever. Ten different nations assembled for the Bible Lectureship. Lectures were streamed of the lectureship via Facebook and had nine different nations watching online. The goal was to expose the world to Four Seas and have others want to join. People reached out to the school and desired to know more and to attend the 2020 lectureship. One person was baptized while he was there and the seed of the gospel was sown.

Deacons in December 2019 were Rickie Britton, Jim Calahan, Willard Carr, Dennis Collins, Chris Cooper, Phil Glover, Charles Gulley, Nathan Hale, and Mark Woodard.

For the food giveaway this year, members were asked to turn in names of someone they know who is in need of food and then be willing to deliver the box to them.

During 2019, there were eight baptisms and thirteen restorations.

As East Hill looks toward the future the elders selected Caleb Rutherford to work as the Associate Minister. Caleb and Kaylon moved here in May of 2020. Caleb is a 2017 graduate of MSOP. Since their arrival was during the Covid-19 Pandemic they were treated to a Pantry Pounding to help them settle and feel welcomed.

Over the past years, several members of East Hill have left a part of their estate to the East Hill church. Their generosity has provided additional funds for improvements to the facility and supported additional mission work.

Whereas, J. B. Stacy, former Clerk and Master of the Chancery Court of Giles County, Tennessee, and who was Clerk and Master of said Court on May 16, 1876, made, signed and delivered to John G. Ballentine the following deed.

"This Indenture, Made the 16th day of May, 1876, between J. B. Stacy, Clerk & Master of the Chancery Court at Pulaski, for Giles County, Tennessee, of the first part, and John G. Ballentine, of Giles County, State of Tennessee, of the second part, Witnesseth:: That by a decree of said Court, rendered at the September term, 1873, in the cause of Albert Buford & others Complainant, and Delia Taylor & others defendant, the said Clerk and Master did on the 22 day of November 1873, sell at public auction the real estate hereinafter described to the said John G. Ballentine for Thirty nine hundred and forty one and 50/100 Dollars, as appears from the report of said Clerk and Master made in said cause to the February term 1874. And the said John G. Ballentine having paid said sum of Thirty nine hundred and forty one & 50/100 - as required by the decree of said court confirming said report, Now, therefore, in order to carry into effect said sale, in pursuance of said decree, and in consideration of the sum of \$3941.50 dollars paid to said Clerk & Master, the receipt of which is hereby acknowledged, the said J. B. Stacy as such Clerk & Master, hath bargained and sold, and doth hereby transfer and convey to the said John G. Ballentine, and his heirs and assigns forever, a certain tract or parcel of land in the County of Giles and State of Tennessee, situated in the 7th Civil District of Giles County and being lots Nos. 1, 8 & 9 & 6 & 11 of the subdivision of the land of G. D. Taylor, dec., near Pulaski; Lot No. 1 bounded as follows:- beginning at the N. W. corner of the lot on the south side of Madison Street and east side of Childers Street; thence S. 1 W. 6 ch 45 L. to a stake on McCallum Street; thence with the north side of McCallum Street, S. 88-1/4 E. 4 ch. 22 L. to a stake, the S. And, whereas, the said J. B. Stacy, Clerk and Master, failed to acknowledge said deed and the said John G.
